make the Survey valid. Cllr Ham clarified that the percentage response was not key and what
was really critical was the number of people who requested housing. For information he
added that Part 2 of the Local Plan was expected to be issued for final consultation in early
January.

6 Reports

6.1 **PCSO report** – PCSO Mike Storey is now able to extract the Coleford incidents from the overall Frome Rural Beat report and identified that in November there were:

1 attempted burglary

1 dog bite

1 public order offence

1 case of harassment

1 ASB

He asked Cllrs to publicise that in Holcombe there have been incidents of sheep farming equipment being stolen and encouraged the use of marking property.

Warnings had also been issued to moped riders in the village.

The Clerk had written to the PCSO requesting details of crime prosecutions. Mr Storey said that this was very difficult to extract from their records. Cllrs thought this was unreasonable in this day and age and asked him to look at this again.

Cllr Gurd raised the issue of a Nissan Micra which had been parked on the highway opposite the Miners Arms despite having a SORN but the Police had taken no action.

- 6.3 **Mendip District Council report** District Cllrs Philip Ham and Alan Townsend reported that several significant issues were being debated at the Full Council Meeting on 18th December and a further report would be provided. It was noted that the Mendip planning officer has advised that she expects to make her recommendation on the new Co-operative Store application shortly. Also it was reported that the Mendip Scrutiny Board had reviewed a very favourable report of this year's Glastonbury Festival. The weather had been kind, but a number of measures had been put in place to ensure there was no repeat of the gridlock of the previous Festival. Also road safety was being further examined to try to prevent a repeat of the recent tragic accident at Cannards Grave.

7 Planning

7.1 Decisions on Previous Applications

2017/1596/LBC – Single glazed to be replaced with double glazed units, additional window on rear elevation, removal of glazing bars on two windows on rear elevation and removal of partition wall on first floor.

8 Progress report on BMX

Cllr Gurd reported that in his opinion the Pre App had failed, and that following consultation with Cllr Ham and Mendip Planning it had been decided that a full application was necessary. This was now held for drawings to be supplied by the preferred contractor, Rob Wareham.

Cllr Conn reported that we are still awaiting feedback on the funding application to Sport England.

Cllr Gurd advised that to raise further funds a sponsored car wash, was being organised for January, and also a raffle.

9 Reports on Highway and Footpath Issues including

9.1 Update on renovation of Finger post signs

Cllr Pearce reported that work was still in progress on surveying the state of the signs, including access, and a report will be presented once completed.

9.2 Review of the Footpath reports

Mr Stanley presented his report of the Southern footpaths in the Parish. These were considered to be in a better state of repair than those in the North. Mr Stanley was thanked for his report. Both North and South reports will be sent to the Rights of Way team at Somerset County Council.

9.3 Highway Issues

Cllr Pearce reported that he had met with Charlie Higgins from Somerset Highways. He has advised that the resurfacing of Church St is still in the forecast for 2018/19, also some work on Anchor Rd, possibly near the Co-op and the High St pavement, these to be clarified. Charmborough Lane is still being monitored – Councillors expressed extreme disappointment that no immediate work was planned.

Cllr Ham reported that he had been promoting the Coleford Small Highway Improvement Scheme with County Highways as one of his two priority proposals. The other is the Old Frome Wells Road which must receive priority due to the recent fatal accidents there. Cllr Ham has invited Highways for a site visit to review the proposals and consider possible solutions.

Cllr Turner asked for priority for the footpath link outside the old Surgery as this was an important route to the school.

Cllr Gurd also raised the question of the missing pavement section at Goodeaves. Land ownership had been a problem. Cllrs wished to reconsider how to approach this.

10 Freedom of information (FOI) request

The Clerk had reported receipt of a FOI request from Mr R Browning on 8-11-17 requesting all emails sent out by her to the Parish Council concerning him and his farm at Owls Nest. This had been supplied by signed for delivery within 20 working days as required. The response noted that Council Agendas and Minutes were not supplied as the Act considers them to be in the public domain.

Cllrs noted that the result of Mr Browning's appeal against the refusal by MDC of his Section Q application for the conversion of an agricultural building to a dwelling was still awaited.
