#### 12 Confirmation of Insurance cover for Parish Council

The Council is currently insured with BHIB Ltd and is just finishing year 1 of a 3 year contract. Cllr Evans has reviewed the cover and found it to be in order. The premium for the year is £794.46 which is paid by cheque.
