Minutes of the Parish Council Meeting held Wednesday 12th February 2025

Present Cllr Ham (Chairman presiding), Allen, Banks, Douglas-Burke, Evans, Moulding, Paterson,

Pearce, Swords and Townsend.

1. Public Forum

- 1.1 It was asked how Gladman have been allowed additional time to respond to points raised regarding the planning conditions. This would have been agreed with the planning officer.
- 1.2 It was asked if the bridge currently being worked on by Somerset Highways at Vobster was being widened? No, it is understood that the wall is being repaired.
- 1.3 A new entrance has been created at Tan Fam, Ham. Was this part of the planning permission?

Action: Cllr Townsend to investigate

- 1.4 Cllr Townsend confirmed that tomorrow he would be attending the Mendip Country Practice Patients group meeting. He asked if anyone had any points they would like raised. Several councillors said that it was unfortunate that it was no longer possible to see the same doctor each time you visit. Other councillor said that the service they had received had been very good.
- 1.5 Cllr Swords asked the Council if they would consider purchasing a female soldier for the Royal British Legion to be erected alongside the metal Tommy.

3. Declaration of Interest and Dispensations granted since last meeting

4. Approve the minutes from the meetings held on the 15th January 2025

The Clerk had circulated the draft minutes prior to the meeting. It was proposed by Cllr Paterson and seconded by Cllr Pearce that the minutes accurately reflected the meeting and should be signed by the Chair.

6. Co-option of Councillors

There were no applicants to consider. There are currently 2 vacancies which the Clerk will promote.

7. Reports

7.1 <u>Somerset Council</u>

Cllr Ham reported that work continues on the restructuring with 600 jobs already gone. Services will be cut, fees for all services will be increased to help bridge the financial deficit. Central Government have agreed that Somerset Council can increase the precept by 7% and will be working on providing a balanced budget for agreement at the full council meeting on the 5th March 2025.

Somerset highways have submitted a response to the planning office highlighting no less than 9
issues which they require to be addressed. It was agreed that the Council would submit a response to the planning office also highlighting that the highway matters have not been addressed by Gladman.

9.2 <u>Discuss response for the Mendip Local Plan Part II, Limited update hearing session – Cllr Townsend confirmed that the Parish Council will send a representative to the Hearing sessions on Tuesday 11th, Wednesday 12th March and on Thursday 13th for the afternoon session relating to the CL2 site at Coleford. A draft statement will be put together for submission by the 20th February.</u>

9.3 <u>Review previous applications -</u> The Clerk provided an updated spreadsheet showing current status of active planning applications.

10. Highways including

- 10.1 <u>Councillor update</u> Cllr Townsend said that the following issues were reported as follows:
 - Anchor Rd pothole by crossing at Beacon View filled
 - Kilmersdon Common flooding at junction
 - Charity Lane junction flooding again blocked by debris apparently
 - Vobster Cross 3 potholes reported
 - Tinkers Lane flooding reported again
 - Cherry Gardens Lane clippings flooded onto road
 - Charmborough Lane overhanging trees cleared

- Kings Head bridge date for repair requested
- Street Lights Anchor rd/Brewery Lane programme for repair requested
- Street Lights Goodeaves/Stockhill 7 defective lights reported
- Brewery Lane/Dark Lane junction pothole reported and repaired
- Pitcot Lane flooding and blocked drain reported at Barlake Farm
- Stoke Bottom two potholes reported
- Gurney Slade major pothole reported on Tape Lane

It was noted that since the closure of Mells Road at Vobster there had been a noticeable increase in traffic through the village.

Local Community Network – It was asked if a date has been agreed for the Highways Sub Committee meeting. It was agreed that we should request a meeting with Charlie Higgins of Somerset Highways

Cllr Moulding asked why the footpath next to the bridge by the Mill was closed. The Parish Council Footpath Warden had inspected the damage to the bridge and due to the severity suggested that Somerset Rights of Way inspect, which they have done and subsequently closed the footpath.

10.2 Report of any new issues

Councillors raised the following additional items to be reported - Dores Hill - edge erosion plus potholes Charlton Road - 2 sunk drains near the Hackmead Farm entrance Haydon Road - large patches eroded.

The Clerk had received a complaint regarding the street lights that were not working at Stockhill but as mentioned above these have already been reported.

11. Update on the Coleford Menshed

The Clerk has created an event on Facebook and placed posters around the village for the open meeting planned for Saturday 1st March 2025 at The Hub starting at 10.30am. The meeting is open to men and women. Councillors are encouraged to help spread the word. Light refreshments will be available, which Cllr Ham is to organize.

Cllr Pearce and Cllr Townsend will meet with Patrick Abrahams (UK Men's Sheds Association-Ambassador) on 14th February to agree the agenda and marketing presentation material.

12. Update on the Coleford Allotments

The Clerk has invoiced all allotment holders and has been following up on the few that are outstanding.

Three allotment holders have nature ponds and they have each been asked to make them safe in accordance with the new rules before the end of the month.

The tree that fell during the storm and damaged the outer boundary fence has been cut down but the fence is yet to be repaired. This has resulted in muntjac deer entering the allotments. Amy from Vobster Quay said in December that they would repair the fence but it might be a few weeks before it could be completed. The Clerk has written again asking for an update on when it will be repaired but has as yet received a response.
